Position Summary

Provide support to the 30 Days to Family® Specialists and Kinship/Foster families in an area of four (4) to six (6) Ohio counties. This will be accomplished by partnering with the county agencies to surmount barriers to offer real time kinship support to ensure placements, develop a network of supports for kinship families, and enhance county recruitment efforts. Throughout the process, the Family Support Specialist will be in frequent contact and collaboration with county partners, Family Specialists, Kinship families and potential resource parents. As the need arises, the Support Specialist will assist in guiding families through licensure and providing them with additional information that will help them provide the best care children in county custody.

Essential Functions

- Provide support to the Family Specialist and family in these five areas of concentration
- Material and financial support
- Mental health and crisis support
- Resource/support groups
- Navigation of systems (TANF, KPI, Food Assistance, Child Care and Housing)
- Support, follow up and training * Develop a network of sustainable Kinship supports in the same five concentration areas listed above.
- Has knowledge of and ability to educate families about the unique issues surrounding foster care, adoption and guardianship, child development, loss, grief, attachment, and trauma.
- Has proven ability to partner with the family in their home environment.
- Collaborates with partner counties to enhance existing recruitment, licensure and retention processes.
- Follows up with families via phone and/or email to find out if they have additional questions or if they are in need of any additional support through the licensing process.
- Evaluates assimilation of program philosophy and practice within the county agency

Department Specific / Non-essential Functions:

- Answer and respond to phone calls and emails from county partners, 30 Days to Family® Specialists and families.
- Keep work calendar current and maintain records.
- Participate in agency meetings, functions, and activities as required.
- Complete assigned office tasks.
- Complete ongoing education as approved by or assigned by supervisor.
- Other duties as assigned.

Minimum Requirements:

- At least a bachelor's degree in social work, drug and alcohol education, counseling, psychology, or criminal justice.
- 5+ years child welfare experience, including licensing resource families.

- Computer skills to enter and retrieve information
- Excellent written skills
- Ability to complete monthly and quarterly reports, and meeting minutes
- Sound organizational skills in order to maintain up-to-date information about projects and families
- Ability to be a team player
- Ability to self-initiate and work independently
